<u>Licensing Statistics & Program Review</u>

Attachments 11a & 11b reflect the licensing population and application stats for the last 3 quarters of the 2024/25 Fiscal Year. Currently, there are 16,565 licensed osteopathic physicians and surgeons; 1,174 postgraduate training licensees (PTL); 1,269 fictitious name permits; and 1 Temporary Osteopathic physician and surgeon license. As we enter the last quarter of the Fiscal Year, staff have been preparing for the submission of all initial physician and surgeon and "transitional" Postgraduate Training applications. I am hopeful that the margin of variance between the receipt and approval of the full unrestricted physician and surgeon licenses will be minimal as the application stats continue to stabilize. Nonetheless, there are 312 pending initial applications with 48 of those requesting expedite services. The application breakdown is as follows:

Application Stats

- Postgraduate Training License (65 applications)
- Osteopathic physician and surgeon (247 applications)

Expedite Service Requests

- Medically Underserved Area (37 applications)
- Military Veteran (11 applications)
- Abortion Services (1 application)

Director Calderon noted in her report that the Board went through a reorg in February, resulting in the Licensing Unit graciously receiving the redirect of three (3) board staff (Sanjay Naresh, Jaime Nichols, and David Moran). Over the past 2 months I've worked with staff to update CME Compliance and Fictitious Name Permit (FNP) documents as well as revise certain aspects of our BreEZe VO transactions to ensure that the

Board is following legislative and regulatory mandates. Staff will soon begin completing UAT testing, to verify that all requested revisions have been completed within the VO Transactions for initial and renewal applications for the following:

- PTL applications (online)
 - o Licensee pocket license self-query via BreEZe Portal
- Physician and surgeon application (online)
 - Removal of Postgraduate Training modifier placement*
 - o Update to Information Privacy Act and Attestation language
- Physician and surgeon Renewal Application (online)
 - Removal of hold placed on licensee profiles for 36-month compliance*

Ideally, if time permits I would also like to go through the review and revision of the Fictious Name Permit application (initial) so that we are able to go live by Q2 of FY 25/26.
