**NOTICE OF AVAILABILITY OF MODIFIED TEXT OF PROPOSED REGULATIONS  
AND ADDITION OF NEW DOCUMENTS TO THE RULEMAKING FILE**

**NOTICE IS HERBY GIVEN** that the Osteopathic Medical Board of California (hereafter referenced as “Board”) is proposing modifications to proposed regulations at Title 16, California Code of Regulations (CCR) sections 1635, 1636, 1638, 1639, 1640, 1641, 1646, 1659.30, 1659.31, 1659.32, 1659.33, 1659.34, and 1659.35 related to Continuing Medical Education and Audits and Cite and Fines. These regulations were originally posted to the Board’s website on November 21, 2025 and published in the California Regulatory Notice Register on November 22, 2025. Thereafter, modifications to the originally proposed text were approved by the Board at its February 13, 2025 meeting.
